\_\_\_\_\_ I agree to provide proof of my dog's Rabies, Distemper series (DHLPP or DHPP), and Bordetella (Kennel Cough). Exceptions are made for puppies too young to receive Rabies. I understand failure to provide proof of these vaccines will result in my evaluation being rescheduled.

\_\_\_\_\_ I understand there are no guarantees with dog behavior, and I will follow the direction of **AWESOME DAWGS DOG TRAINING** for the duration of my time at **THE DAWG PARK**. I agree to keep my focus and attention on my dog at all times.

\_\_\_\_\_ I understand that **THE DAWG PARK** is not meant to socialize unsocial dogs. If my dog is fearful or aggressive towards people or other dogs, he/she might only be eligible for private play.

# Release of Liability

## TERMS, CONDITIONS and RELEASE OF LIABILITY

Awesome Dawgs Dog Training, LLC, referred to as ADDT

### Terms and Conditions:

1. **Fees for Group Training, Private Training, Play Sessions, Events and Lectures are non-refundable.**
2. ADDT may cancel service and agreement if client: fails to pay; has poor attendance or frequently reschedules; is disruptive or behaves inappropriately; fails to follow recommended training advice and techniques.
3. Clients enrolled in training sessions are expected to maintain and reinforce training outside of sessions.
4. All ADDT clients agree to protect their dogs with the following vaccinations and will provide ADDT with proof of these vaccinations or titers testing where appropriate: DHLPP (Distemper, Hepatitis, Leptospirosis, Parainfluenza, Parvovirus) Rabies and Bordetella. Anyone not in compliance with our immunization policy will be denied enrollment in our program.

### Release of Liability:

1. The use of all training spaces for classes, or any other use by anyone other than the staff of ADDT will always remain subject to the approval of the ADDT, staff or management. Any inappropriate use of the space as determined by the staff by either dogs or people is justified cause for termination of the agreed upon use.
2. This release applies to properties, facilities and holders of land use agreements that ADDT has secured, contracted or own for use as a dog training and exercise space. The terms and conditions are agreed upon as third party additionally insured, hold harmless agreements with Small Business Insurers of the Carolinas and land use agreements on file at ADDT. The properties include, but are not limited to: 55 Lake Road, Fleetwood Pa; 3052, 3050 and 3044 Pricetown Road, Temple Pa.
3. I hereby grant ADDT, their legal representatives and assigns (including but not limited to any agency, client or publication) irrevocable permission to publish photographs of me taken at ADDT and their additional training and play locations. These images may be published in any manner, including (but not limited too) advertisements, periodicals, social media outlets and ADDT website.

**I do hereby waive and release ADDT and their agents, officers, employees and holders of the aforementioned Land Use Agreements from any and all liabilities of any nature. I agree to take complete responsibility for the actions of my dog, and myself, before, during and after contracted services, and/or center rental. At no time will ADDT and their agents, officers and employees be held liable or responsible for the actions of me, my dog or any other person who accompanies me to classes, play time, center rental, or any other form of professional service offered by ADDT.**

## GUIDELINES

- Handlers must clean up after their dog.
- Park players must check in at the front desk before entering the park.
- The following items are not permitted: glass containers, alcohol, people & dog food/treats, children under 12, firearms, weapons, smoking, bicycles, skateboards, roller blades, cell phone use (calls, texting, etc.)
- Dogs over the age of 6 months must be neutered, unless you have a private reservation.
- One dog per person during open play sessions.
- Dog handler must be 18 years or older.
- All park visitors must be registered, paid and fully vaccinated in order to enter the park.
- All gates must remain securely closed.
- Dogs that are in the play space may not be on leash, wearing harnesses or other training devices.
- Dogs must be 4 months of age or older to be in outdoor park.
- Handlers must refrain from running.
- Handlers must have their dogs in sight and be attentive to their dog's interactions at all times.
- No human or animal aggressive dogs are permitted.
- Awesome Dawgs reserves the right to prohibit or remove any dog at any time at their discretion.
- No females in heat permitted in the park at any time.
